RE: ELECTION RESPONSE PLAN OVERVIEW

Chris Zimmerman,

As discussed, I am providing you with an overview of our Election Response Activities planned for implementation on October 16, through November 3rd, 2020.

On October 16, 2020 we will meet with the Nye County Clerk to ensure we are aware of the changes she might have made over the last few weeks or days prior to early voting. After the voting equipment is set into place periodic patrols will ensure the equipment and buildings are not compromised and the Sheriff's Auxiliary Unit personnel will mark out the one hundred (100) foot perimeter around the Pahrump voting area.

On October 17, 2020 we will have at least two Sheriff's Auxiliary personnel in and around the polling place, Bob Ruud Community Center, before opening, from 0630 hours until after closing at 1900 hours. These personnel will assist voters and ensure personal rights are not being infringed upon. They are equipped with a radio and are trained to request deputy assistance if they see a problem brewing. These personnel will be assigned to two hour shifts to ensure they remain alert during their shift.

In addition, deputies and their Sergeant have been assigned to randomly assess the crowd from crowd assembly until the polls close. They will be in the area at least once per hour on a random basis throughout the process. If there is any controversy, a deputy will be assigned to the voting location.

At the end of each days voting, the ballot movement will be attended by two sworn personnel and the County Clerk's staff in accordance with her wishes.

All other early voting areas within the county will be handled in much the same manner with periodic patrols unless a problem arises and then a deputy will be assigned. The one hundred (100) foot perimeter will be set up to ensure no campaigning is taking place within that area.

This process will continue from October 17 through October 30, 2020.

On November 2nd, polling places will be set up and periodic patrols will be implemented to ensure the equipment and buildings are not compromised. The one hundred (100) foot perimeter will be set up for each polling place.

On November 3rd, 2020, the polling places will be Amargosa Valley Community Center, Beatty Community Center, Pahrump Bob Ruud Community Center, Round Mountain Don Simpson Center and Tonopah Convention Center.

The initial staffing will remain the same for Pahrump and periodic patrols will remain in effect for the outlying areas. At the end of voting the ballots and electronic media will be secured and transported to be counted by two or more Nye County Sheriff's Deputies.

Patrol and Command Staff are aware of the possibilities and a contingency plan is in place to deter escalation and manage larger crowds if the need arises.

Persons expressing their rights will be allowed to do so until their form of expression places people or property in harms way. Violence and its consequences will not be tolerated. Law abiding citizens will be protected.
